Data Collection:

CyberX Private Company collects personal data only for legitimate business purposes and with the consent of the individual, where required by law.

Data Use

Personal data collected by CyberX Private Company will be used for the following purposes:

- To recruit and manage our employees
- To comply with legal and regulatory requirements

Data Retention

CyberX Private Company will retain personal data only for as long as necessary to fulfill the purposes for which it was collected, or as required by law.

We have implemented appropriate technical and organizational measures to ensure that personal data is securely deleted or anonymized when it is no longer needed.

Data Sharing

CyberX Private Company may share personal data with third parties for legitimate business purposes, such as service providers and partners. We will only share personal data with third parties who are bound by appropriate confidentiality and data protection obligations.

Data Security

CyberX Private Company has implemented appropriate technical and organizational measures to protect personal data against unauthorized access, alteration, disclosure, or destruction.

Our measures include:

- Secure storage of personal data
- Use of encryption for transmitting personal data
- Regular backups of personal data
- Restriction of access to personal data to authorized personnel only

Data Access and Correction
